If the Company does not receive the duly completed Reply Form from you (or another response from you indicating that you object to the Email Option) by 31 January 2024, you will be implied to consent, until you inform the Company otherwise by reasonable notice in writing to the Hong Kong Share Registrar at the above address or by email to 3683-corpcomm@unionregistrars.com.hk, to have elected to receive printed notification letter of the publication of the Corporate Communications. In future, when the Company publishes any Corporate Communication on the Websites, it will only send to you a notification letter that the Corporate Communication has been made available on the Websites. The notification will be sent to you by email (if you have provided a valid email address) or by post (if you have not provided an email address or the email address is invalid) at your address as it appears in the Company’s register of members maintained by the Hong Kong Share Registrar.

Actionable Corporate Communications^(Note) are sent to you individually and in electronic form if valid email addresses have been provided to the Company. If no valid email address has been provided, an actionable Corporate Communication will be sent to you in hard copy form. Please be reminded to provide valid email addresses to the Company’s Hong Kong Share Registrar to receive Corporate Communications in a timely and sustainable manner.

You may at any time send your request in writing to the Company (c/o its Hong Kong Share Registrar at the above address or by email to 3683-corpcomm@unionregistrars.com.hk) to request for printed copy of the Corporate Communications. If you have received notification of the publication of the Corporate Communications on the Websites and for any reason have difficulty in gaining access to the Corporate Communications on the Websites, the Company will upon request send the Corporate Communications to you in printed form free of charge.
