## INSIDE INFORMATION

### SIGNIFICANT DECREASE IN LOSS

This announcement is made pursuant to Rule 13.09 of the Listing Rules and the Inside Information Provisions under Part XIVA of the SFO.

The Board of the Company wishes to inform the shareholders of the Company and potential investors that based on the Board's preliminary review of the unaudited consolidated management accounts of the Group and other information currently available, the loss attributable to shareholders of the Company for the six months ended 30 September 2017 is expected to significantly decrease by over 60% as compared to the loss attributable to shareholders of the Company for the corresponding period in 2016.

**Shareholders of the Company and potential investors should exercise caution when dealing in the shares of the Company.**

This announcement is made pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "Listing Rules") and the Inside Information Provisions (as defined under the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571, Laws of Hong Kong) (the "SFO").

The board of directors (the "Board") of Great Harvest Maeta Group Holdings Limited (the "Company", together with its subsidiaries, the "Group") wishes to inform the shareholders of the Company and potential investors that based on the Board's preliminary review of the unaudited consolidated management accounts of the Group and other information currently available, the loss attributable to shareholders of the Company for the six months ended 30 September 2017 is expected to significantly decrease by over 60% as compared to the loss attributable to shareholders of the Company for the corresponding period in 2016. The significant decrease in loss was mainly attributable to the following factors:

- (1) due to the continuous improvement of dry bulk marine transportation industry, the freight rate and demand picked up significantly. The Group also benefited from the increase in the revenue for six months ended 30 September 2017, recording a gross profit for six months ended 30 September 2017 as compared with a gross loss for the corresponding period in 2016; and

- (2) recovering from the depressed market of dry bulk marine transportation industry over the past few years, the overall second-hand vessel price rebounded strongly in 2017. Therefore, the Group did not make any impairment loss in respect of its vessels for six months ended 30 September 2017.

The Company is still in the process of finalising the interim results for the six months ended 30 September 2017. The information contained in this announcement is based on the Board's preliminary review of the unaudited consolidated management accounts of the Group and other information currently available, which have yet to be audited or reviewed by the Company's auditor and may be subject to adjustments. Shareholders of the Company and potential investors should read the Group's interim results announcement for the six months ended 30 September 2017 carefully, which is expected to be published by end of November 2017.
